1. VICE PRESIDENT (One-Year Term)

Award Program

The purpose of the NEMATYC Student Mathematics League Recognition Awards Program is to foster extracurricular mathematics learning opportunities for students through participation in the AMATYC Student Mathematics League (SML). The top-placing student in the AMATYC SML Competition at each school in NEMATYC's region receives a \$100 award. The only criteria is the student must participate in both the Fall and Spring competitions. The top school receives the Lois A. Martin NEMATYC Student Mathematics League Award.



COVID-Part of the Tragedy

You probably have heard of John Horton Conway, and perhaps of his "Game of Life". Tragically this mathematical wonder died April 11, 2020 at the age of 82 from complications from COVID-19.

At https://playgameoflife.com/ you can experiment with the Game of Life – a fascinating game with only three simple rules that produce very interesting patterns on a grid, growing, moving, decaying and dying.

When I taught computer programming it was sometimes a project for my students, a very good exercise in manipulating arrays.



Interested in Jokes

Did people 2,000 years ago tell jokes like we do today? Did they have a similar sense of humor? Did they talk about mathematics? Questions like this interest this editor.

In 400 AD two Greeks wrote a book of jokes, called Philogelos (loosely translated as "the Joker")*. Did you hear the one about the idiot moneylender who called in his debts? He ordered a sailor to buy him a cremation urn and two smaller urns for his eight-year-old sons, which would grow to the right size with interest.

I didn't say it was funny, but it is similar to jokes we might hear today, whether in good taste or not. But I cite this example from that book because it mentions things growing with interest. A quick web search notes that Pompeii has graffiti which talks about loans with interest rates of 45 to 75 percent, and that the Romans capped interest rates on cash loans at 12%—more humane than the credit cards on which our fellow citizens carry much debt.

One other tidbit I have come across recently is that Sir Isaac Newton is said to have laughed only once in his life—when someone asked him what use he saw in Euclid's *Elements*.

Proposed Amendments to the NEMATYC Constitution

The following amendments to the NEMATYC Constitution are proposed by the Executive Board. They will be voted on at the next NEMATYC business meeting, to be conducted during the conference.

- i. be elected to a two-year term.
 ii. be responsible for the official correspondence of the Association.
 iii. maintain the records of the Associa-tion and transmit these records to the succeeding Secretary iv. take minutes of the meetings of the Association.
- v. maintain an up-to-date copy of the Constitution, and in collaboration with the Executive Committee, make changes as voted by the members
- d. The Treasurer will:
- i. be elected to a three-year term.
 ii. be in charge of all the financial records and funds of the Association.
 iii. surrender the financial records of the Association for annual auditing to a designee appointed by the Executive Committee.
- iv. give a report at the annual business meeting.
- v. retain an up-to-date membership list
- vi. receive dues payments.

- a. The President will:
- i. be elected to a two-year term.ii. assume the role of past-president at the conclusion of the term.
- This change moves many of the officer responsibilities from the constitution to the policy manual. Some officer responsibilities could change over time and we do not want to necessitate a vote for a constitutional change in order to make such changes.

It is not typical to find these responsibilities listed in a constitution in other non-profit orgs.
